

GOODVIEWCOTTAGES BIKE RENTAL POLICIES:

The customer hereby rents bicycles from GoodviewCottages Bike Rental subject to all terms and conditions of this agreement:

1. GoodviewCottages Bike Rental rents bikes only prior booking. Rental day period starts at 10:00 h and ends at 20:00 h. Overnight rentals can be agreed with GoodviewCottages Bike Rental.
2. The rented equipment will be pickup and delivered to 1319 gulfshore PKWY.
3. The bicycles will be delivered and picked up on the day and time according to the booking or rental agreement. Customer delays, both on delivery and pick up of bikes, without notifying GoodviewCottages Bike Rental, will result in an additional charge of 10\$ if delivery & pick up service must be re-programmed plus the corresponding extra hour /fraction of hour rental rate.
4. At the end of the rental period the customer must return the bicycles to a GoodviewCottages Bike Rental representative identified with the original rental contract form

RESERVATION, PAYMENT, DEPOSIT AND CANCELATION

5. Bike reservations must be done with enough anticipation in order for GoodviewCottages Bike Rental to confirm availability. But, if the customer needs a bike on the same day he/she may call 514.887.9968 to check for availability. Group confirmations over 4 bicycles require a 50% advance payment deposit.
6. **Method of payment: cash or interac (if previously requested), at the delivery of the bikes for the complete rental period reserved.**
7. The customer signing the rental contract must be over 18 years old. Underaged customers must be accompanied by an adult.
8. On delivery of the bike/s the customer must read, accept and sign the rental agreement. The customer will be asked to pay deposit for the rented equipment. At the end of the rental period, the customer accepts a charge for any missing or broken items at market prices. GoodviewCottages Bike Rental will accept a cash / interact deposit of 200\$. The deposit will be refunded if the rented equipment is returned in the same conditions it was procured. If the missing or broken items exceed the deposit amount, the customer must settle the balance.
9. Cancellations without charge are only admitted 24 h before the programed delivery time. Cancellations after this time or at the moment of delivery will be fully charged according to the customer's reservation. Group confirmation deposits are non-refundable.
10. No refund will be made for early return of the bicycles.

RENTAL EQUIPMENT

11. The rented bicycles and equipment may only be used by the designated customer and the members of his/her party as mentioned in the Rental Contract.
12. The customer is obliged to take good care of the rented equipment and to protect it from damage, loss or theft. In case of damage, loss or theft of the bicycle/s, components or any of its parts, GoodviewCottages Bike Rental will charge the customer the full cost of the missing items at market prices.
13. The customer is obliged to lock the bicycle/s properly at all times when unattended, passing the lock through the frame and attaching the bike(s) to something fixed to the ground like a post or fence, if allowed, or else, a bicycle parking. It is highly recommended to keep the bikes secured at all times specially during over-night rentals.

LIMITATION OF LIABILITY

14. The customer is responsible for adequate personal insurance coverage for risks that may occur during the rental period. GoodviewCottages Bike Rental is not liable for any claims for body injury or harm, accidents, damage caused to third person property or loss of personal belonging caused by equipment, weather, sickness, or any other causes whatsoever beyond the control of Bike Rental Barcelona.
15. The customer and his/her group must respect Canadian traffic regulations. Any ticket or fine due to incorrect use of the bicycle will be completely assumed by the customer.
